Important notes for Neptune Pacific BAF/LSR:

- For Australia, New Zealand, and South Pacific to American Samoa (Pago Pago), the BAF will be effective from 1 October 2026.
- For Australia, New Zealand, and South Pacific to the Cook Islands, a BAF of 26.3% and a Currency Adjustment Factor (CAF) of 19.4% is applicable on the Base Ocean Freight.
- For Asia, Latin America, Africa, Middle East to South Pacific (no service offered to Pago Pago, American Samoa), the bunker charge is a Low Sulphur Recovery (LSR) charge.
- For all shipments to/from the USA West Coast, an Emissions Control Charge of USD 25/TEU is also applicable.
- For Norfolk Island imports/exports, BAF is on a per RVT basis.
